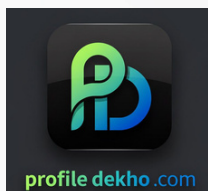

## GUIDELINES FOR SUBMISSIONS

The abstract shall not exceed 200 words. Full papers shall not exceed 8–12 pages, including tables, charts, diagrams, etc. The manuscript must be in Word format, using Times New Roman, 12-point font, on A4 size paper. Line spacing shall be 1.5, typed on one side only. Only electronic submissions of articles will be accepted.

Papers shall have not more than two authors, and each author must register separately. Both conceptual and empirical research papers are invited. The research paper should preferably follow a standard research format, including the need for the study, objectives of the study, hypothesis (if any), methodology, techniques of data analysis, findings/results, conclusion, references, and statistical tables, in that order. A soft copy of the paper must be submitted to the following email ID: [conference.tlwwlj@gmail.com](mailto:conference.tlwwlj@gmail.com).

Both the abstract and the full paper must be submitted in Word format.

Selected papers will be published in an ISBN book upon payment of the applicable publication charges.

- Paper length: 8–12 pages (including references)
- Submit in Word format following standard publication guidelines
